 - All fees are quoted in Saudi Riyals (SAR) and are inclusive of VAT, if applicable.
 - Payment methods include bank transfers, credit/debit cards, or digital wallets as permitted under KSA regulations.

5. Cancellations and Refunds

- All payments made to 150Frames are non-refundable.
 - Once a booking is confirmed and payment is made—whether full or partial—no refund will be issued under any circumstances, including client cancellations, no-shows, or changes of mind.
